Rain gardens, riparian buffers, and runoff management were the highlights of this year's Schuylkill River Restoration Fund Bus Tour!

The first stop was Charlestown Playhouse where Development Director, Allegra Churchill, shared an overview of the project and introduced Jessica Wolff and Don Pell of Donald Pell Gardens, who designed and built the series of gardens. In addition to the water quality benefits these gardens provide by filtering water entering Pickering Creek, the engagement with the environment and educational value they will continue to provide for the Charlestown Playhouse students, parents, and faculty were evident as the squeals of delighted children filled the background.

Douglass described the engineering challenges and accomplishments of his team working to modify the infrastructure below ground and including stormwater inlet filters that capture sediment.

### Schuylkill Sojourn



Kara commented on her experience, "The Sojourn was an incredibly unique way to experience the Schuylkill River. As I reflect on my experience, I remember a welcoming community of fellow Sojourners and feeling excitement being on the water, though it did become a challenge for me at times. I don't think I paddled a total of 25 miles in my entire life until that week and now I completed 112 miles in just 7 days."

## Schuylkill Acts & Impacts 2022

Schuylkill Acts and Impacts is a week-long expedition for high school students representing all 5 counties of the watershed. Alexa Smith, Natural Resource Conservationist with Schuylkill Conservation District, co-leads this program and shared these highlights from this year's program.

"Throughout the week, students study the impact of legacy coal mining on water quality, agricultural impacts including erosion and manure management, the role of land preservation in watershed health, and the impacts of stormwater and impervious surfaces on water resources."

"Recreation and fun are also part of the week, as the students kayak sections of the Schuylkill River and camp in state parks and nature preserves throughout the watershed.
