CURRENT OPPORTUNITIES

EPA Clean Water State Revolving Fund – PENNVEST (Rolling: 4 cutoff dates per year)

Low interest loans to fund projects for the construction/maintenance of wastewater treatment facilities, stormwater management projects, nonpoint source pollution controls, and watershed management.

EPA Section 319 Nonpoint Source Management Grants Program – PA DEP (Aug. 9, 2019)

Grants for projects that address nonpoint source pollution originating from agriculture, stormwater runoff, and stream channel degradation.

RECURRING OPPORTUNITIES

Schuylkill River Restoration Fund – Schuylkill River Greenways (Jan. 1 – mid-February for letter of intent)

Grants to government agencies or non-profits for projects that improve the quality of water in the Schuylkill River Watershed, including stormwater runoff, agricultural pollution, and AMD.

5 Star and Urban Waters Restoration Grant Program – National Fish & Wildlife Foundation (Jan. 31)

\$20,000 - \$50,000 for ecological improvement and community outreach projects including wetland restoration, tree plantings, stream monitoring, green infrastructure, and stormwater runoff management.

Montco 2040 Implementation Grant Program – Montgomery County (typically due March 1)

\$10,000 - \$200,000 to support local municipality projects within Montgomery County.

Environmental Grant Program – PA American Water (typically due late March)

Up to \$10,000 for source water or watershed protection projects within an American Water service area.

Delaware River Program – National Fish & Wildlife Foundation (typically due mid-April)

\$50,000 - \$500,000 for habitat, community, and water quality improvement projects including agriculture conservation, green stormwater infrastructure, and innovative stream restoration through two competitive funding opportunities: the Delaware Watershed Conservation Fund and the Delaware River Restoration Fund.

Watershed Restoration and Protection Program – PA Department of Community & Economic Development (Feb. 1 – May 31)

Up to \$300,000 for the implementation, repair, upgrade, or maintenance for Best Management Practices for agriculture, stormwater, stream bank and channel restoration, and stream monitoring. Must have 15% match.

Growing Greener – PA DEP (typically due mid-July)

The largest investment of state funds in Pennsylvania to address environmental concerns, including watershed restoration and protection.

TreeVitalize Watersheds Grant Program – PA Horticultural Society (typically due mid-November)

Grants for tree planting projects along stream corridors, headwaters, and naturalized stormwater basins within the five-county southeastern PA region. Projects should focus on water quality and wildlife habitat improvements. Must have 25% match.
